



elections @IOWADOT

- Applies to Engineering, Architecture, and related services selected according to the Brooks Act
- Procedures are defined in Policy 300.12
- The policy and other relevant information is posted here: <u>Consultant/Designer Resources</u> Home (iowadot.gov)
- Process follows lowa Code 73.15-73.21 and 23CFR part 172
- The policy is approved by FHWA each time it is revised



Selection Types



- Emergency Rarely used
- Sole Source Rarely used
- Small Contract Selection
- Complete Selection

Small Contract Selection @IDWADOT

- Occasionally used, but normally we use on-calls
- Limited to < \$150k estimated contract
- Review panel meets
 - Minimum of 3 consultants are considered
 - The panel determines what information they need to make the choice
 - Internet searches
 - Pamphlets or marketing materials
 - Request information from firms
 - Interviews

Full Selection Process



- Most used process
- Policy is structured to
 - Change the selection team members each time
 - Encourage different perspectives on the team
 - Minimize bias
- Maintain a wide group of firms who are qualified to perform DOT work

Write an RFP



- The RFP is written by the bureau requesting the services. They
- Fill in details of the services request
- Choose the scoring criteria.
- The consultant coordinator checks that the requirements
 - Seem reasonable
 - Meet federal and state regulations
 - Include required language

Post the RFP



- •The RFP is for at least 2 weeks (usually)
- Notifications about the RFP are sent out to our email subscription list
- All Q&A are handled through the RFP website



Selection Team



- Members
- -3 or 5 members
- 1 from the requesting office (selection team leader)
- -1 from outside the division or a district office
- -No more than 1 person from any office
- The team reviews and scores proposals separately

Selection Team Meeting



- All proposals are discussed
- Consensus ranking is established
- The Consultant Coordinator facilitates the meeting and ensures the process is uniform and fair
- Pregualification review and determination
- Pregualification is required by FHWA
- Sets a 'bottom' of the list for the Steering Committee
- Committee members are instructed to direct inquiries to the Consultant Coordinator

Steering Committee



- Members
 - Division Director or Asst Division Director
 - Bureau Director from the requesting office
 - District Engineer (if it is district specific work)
 - Consultant Coordinator
 - Others are invited on occasion
- The Selection Team Leader presents a summary of the Selection Team's discussion and scoring. Consultant Coordinator may comment
- Steering Committee ranks the firms

Steering Committee



The consultant steering committee is responsible for reviewing the consultants ranked by the selection committee; determine the final ranked list, and documenting its decision. In carrying out these duties, the steering committee shall consider not only the selection committee's scoring but other factors such as:

- A consultant's ability to accomplish the work in the required time.
- The volume of work a consultant has with the Department, both existing and potential.
- The Department's goal of having an expanse of experienced consultants capable of providing quality services to the Department.
- Other items unique to the particular contract

Notification of Results



- The Consultant Coordinator
- Documents the final rankings the selected firms and 2 alternates are listed
- Notifies the firms who submitted proposals
- Sends scoring information to firms who were not listed on the selection results
- Posts the results on the RFP website

Dispute Resolution



- Complaints should be submitted to the Consultant Coordinator in writing within 15 days of the selection notification. Supporting evidence should be included.
- The Consultant Coordinator will notify the selected firm of the complaint and inform them that negotiations can continue at no risk to the DOT
- DOT management will consider the complaint and resolution
- If federal funding is anticipated for the engineering contract, FHWA will concur with the resolution
- The Consultant Coordinator will notify the consultant of the resolution

- Our process is structured to involve a variety of people, so detailed feedback from one reviewer may not be beneficial the next time



Year End Estimates








